### Private Detection Contract

This Agreement is entered into by and between Detection K-9, Inc., a Virginia corporation ("DK9") and Owner to provide the following services at the following Inspection Area:

Payment Due: Upon execution of this agreement.

Inspection Services': DK9 will provide the following Inspection Services for the following substances:

- Marijuana
- Heroin
- Cocaine
- Methamphetamine
- MDMA (ecstasy)
- Barbiturates

DK9 will only be inspecting the Inspection Area identified above – not any other area at the Property Location.

Confidentiality: DK9 agrees to keep confidential all information acquired in providing the services hereunder. However, Owner understands it is possible that if a substantial amount of illegal substance is found, it is the Owners responsibility to report finding to the local law enforcement authorities. DK9 agrees that it will not publicize or report to any one person or entity its findings at the residence at issue, which includes all branches of law enforcement. All of its findings will remain confidential unless agreed upon by said owner.

Owner understands if DK9 dogs point and it false, means that an illegal substance was there, leaving residual odor, but is not there presently.

Owner agrees to secure any and all household pets in an area of the house that is not subject to narcotics inspection. Owner further agrees to escort DK9 Handler into the area of the property to allow DK9 Handler to inspect area for safety hazards, chemicals and/or unsecured pets prior to bringing DK9 dog into property for narcotic inspection.

Representations: Owner represents it is the owner or tenant of the Property and has full legal authority to allow DK9 to provide the services contemplated hereunder. If for any reason this representation is not true, Owner shall be responsible for all damages and shall indemnify, release and hold DK9 harmless for the same.

This agreement may only be amended in writing signed by all parties. If DK9 reaches this agreement, its damages shall be limited to its fee being charged hereunder, and it shall not be liable for any other damages, incidental or consequential. If DK9 has to enforce any payments due from Owner hereunder, DK9 shall be entitled to reimbursement of all costs, including reasonable attorney fees, incurred in collecting such amounts due.

This agreement may be signed in more than one counterpart, together, which shall constitute one original. A copy/scan/fax/e-signature shall constitute an original signature.

**Waiver Clause**

As evidence by my (our) signature (s) below, I (we) hereby release Detection K9, Inc. together with its agents, officers, directors, volunteers and employees, from any damage and/or liability in connection with the employment and use of a narcotics detection dog. The terms "employment" and "use" shall include, but not be limited to problems encountered in connection with narcotics detection, the failure of the narcotics detection dog to detect narcotics, and/or damages caused by the dog(s) to property or household articles in or at the property in relation to property damage caused by the detection dog in its execution of narcotics detection. DK9 agrees to waive any potential cause of action or claim against said owner based upon the ingestion of any substance by one of its narcotic detecting dogs at the owner's residence
